## **WHAT IS TIER 1 ENTREPRENEUR VISA?**

Tier 1 Entrepreneur Visa is for individuals who are willing to invest in the Isle of Man (IOM) through setting up of a business or taking over the business & being actively involved in one or more businesses in the IOM.

# DURATION OF VISA

# HOW CAN YOU QUALIFY FOR THE VISA

---

To qualify Entrepreneur Visa, applicant need to score a minimum of 95 points under the Points-Based system.

**75 POINTS: INVESTMENT FUNDS**

**10 POINTS: ENGLISH LANGUAGE ASSESSMENT**

**10 POINTS: MAINTENANCE FUNDS**

- Access to Investment Funds equivalent to £200,000.

- Pass an approved English Language Test IELTS level B1 ( all four components)

- £ 3,310 For Main Applicant

# Entrepreneurial Team

- You and one other person can form an 'Entrepreneurial Team'.
  - Each member of the team may apply to come to IOM as a Tier 1 (Entrepreneur) using the same investment funds.
  - A maximum of 2 principle applicant can form an Entrepreneurial Team.

# SETTLEMENT

Qualifying for  
Indefinite Leave To Remain

- The Initial visa will be granted for 3 years 4 month, and at the end of 3 years applicant will be entitled for further 2 years extension or Indefinite Leave to Remain (if qualify).
- At the end of 5 years period applicant will be eligible to apply for IOM / UK Settlement, also known as ILR (Indefinite Leave To Remain)
- After Receiving IOM / UK Settlement, also known as ILR (Indefinite Leave To Remain), applicant may apply for British Citizenship.

# DEPENDANTS



- Entrepreneur Visa holder is allowed to bring dependants to the IOM.
- Your dependants i.e. your children under age of 18 and your husband, wife, civil partner, or unmarried or same sex partner may join / remain with you in IOM.
- Holder of the visa, along with dependants can live, work or study in the UK. Without Border Restrictions.
- Holder of the Visa may travel and live in the common travel area (the UK, Ireland, the Isle of Man, and the Channel Islands). Without Border Restrictions.

# ADVANTAGES & BENEFITS

- The IOM Tier 1 Entrepreneur Visa allows the holder to start a business or control an already existing business in IOM.
- The Tier 1 Entrepreneur visa holder is only required to invest in business in the IOM after their visa application has been approved and before their application for an extension of stay.
- The investment essential to obtain this visa is significantly lower than the Investor's Visa.
- This Entrepreneur Visa is a potential route to Settlement / ILR in the IOM / UK and even spouse and dependants may accompany the visa holder.
- Spouse or any dependent children are entitled to come to the IOM / UK and obtain Free Education, NHS (National Health Services) and can work full-time.
