- As of January 2015, Canada announced an Express Entry system, wherein skilled migrants can migrate to Canada as permanent residents and take part in their economy.

- Universal Health Care – Most necessary medical expenses are covered through the Canadian universal health care program. These expenses include visits to the emergency room, immunizations, yearly exams, etc.
- Free Education – All children under 18 are entitled to free education in the Canadian public school system.
- Maternity and Parental leave – In Canada, working parents are given time off when a new baby is born or adopted. Women can take up to 12 months of maternity leave and receive 50 to 65% of their normal income. Partially paid parental leave is also available for up to 35 weeks. One parent can take all 35 weeks or both parents can split the allotment of time (i. e. one parent takes 20 weeks while the other takes 15 weeks).
- The principal applicant can make spouse and children up to 22 years part of their immigration application. Moreover, the parents of the main applicant can be sponsored for a Canadian permanent resident visa via Canada super visa.



ELIGIBILITY CRITERIA (EXPRESS ENTRY)

- Be at least 18 years' old
- Applicant can fulfill English language requirements by passing an IELTS test securing a minimum of 6.0 bands in each four modules (reading, writing, speaking, and listening).
- Applicant must have minimum Bachelors Qualification
- Applicant must have at least 1 year of experience (Full time or Part-time)
- Applicant must have funds to maintain themselves (require at PR application) as given below:
 - Applicant must have 12960 CAD maintained before applying for permanent residency application. If the applicant is applying with his/her family, then the following amounts also add to be maintained.
 - For each dependent person - 3492 CAD
- If the applicant meets the requirements listed above, they also must demonstrate that they score a minimum of 67 out of 100 points on the FSW eligibility point's grid.
