

## 1. Visa Overview

Step 1: Apply for 3 Years Initial Visa

Step 2: Receive 3 Years Further Extension\*

Step 3: Receive UK ILR (Indefinite Leave to Remain)

Step 4: Receive UK Nationality following UK Passport

UK INNOVATOR VISA ALLOWS THE APPLICANTS TO COME AND SETTLE IN THE UK BY ESTABLISHING AND INVESTING IN AN INNOVATIVE BUSINESS IDEA IN THE UK

- The initial Visa will be granted for 3 years
- A Further extension of 3 years can be applied before the end of initial 3 years visa
- After completing 3 or 5 years on the Innovator visa, applicant will be eligible to apply for ILR (Indefinite Leave to Remain) in the UK provided he/she fulfils the requirements.
- After receiving ILR, applicant can apply after 12 months for UK Citizenship following UK Passport.
- One or more applicants can form an Innovator team.

The above route to receive British Citizenship/ Passport will be applicable for the main applicant, his/her spouse, and all dependent children under 18 years of age.

## 2. Visa Benefits

- Multiple entry visa
- This visa is a potential route to Indefinite Leave to Remain / Permanent Residency after 3 or 5 years
- British citizenship / Passport for the whole family



Wife / Husband (Spouse) accompany the main applicant

All Dependent Children under the age of 18 years old accompany the main applicant.



Free Medical \* for the whole family

Free Education for Dependent Children

Spouse dependent can work full-time in any Job.



Set up a business or several businesses

Work for your business - this includes being employed as a director, or selfemployed as a member of a business partnership.



## 3. Visa Basic Requirements

#### a) INVESTMENT FUNDS

You have to prove that you have access to at least £50,000. These funds can be from any of the following sources:

- Applicants Own Funds
- Third-Party Funding

#### b) KNOWLEDGE OF ENGLISH

You can fulfill the English language requirement by passing an IELTS test securing a minimum of 5.5 bands in every four modules (reading, writing, speaking, and listening).

#### c) MAINTENANCE FUNDS

You must have at least £1270 maintained for 28 days before applying for this visa. If you are applying with your family, then the following amounts also are maintained for 28 days. for your partner - £285 for one child - £315 for each additional child - £200

#### d) BUSINESS PLAN AND ENDORSEMENT

You must:

• Be capable of demonstrating that your business plan is Innovative, Viable, Credible, and Scalable. • Be Endorsed by an approved body i.e. an organisation with a tradition of helping UK entrepreneurs
