# I. Visa Overview

The Scale-up route is for talented individuals recruited by a UK Scale-up Sponsor, who have the skills needed to enable the Scale-up business to continue growing.

The person must have a high-skilled job offer from a qualifying Scale-up business at the required salary level.

- The initial Visa will be granted for 2 years
- A further extension of 3 years can be applied
- After 5 year you will be eligible for ILR (Indefinite Leave to Remain in The United Kingdom)
- After 12 months you will be eligible for British Citizenship

The Visa will be granted to the whole family (where applicable). Below are some benefits:

- Wife / Husband (Spouse) accompany the main applicant
- All Dependent Children under the age of 18 years old accompany the main applicant.
- Multiple entries visa granted.
- A potential route leading to settlement and UK nationality

TO QUALIFY FOR A SCALE-UP WORKER VISA, YOU MUST:

- Have a confirmed job offer to work for an approved scale-up business for at least 6 months
- Have a 'certificate of sponsorship' from your employer with information about the role you've been offered in the UK
- Have a job offer to do a job that's on the list of eligible occupations be paid a minimum salary in your new job
- You must prove you can read, write, speak and understand English to at least level B1 on the Common European Framework of Reference for Languages (CEFR) scale
- support yourself when you arrive in the UK - you'll usually need to have at least £1,270 available (unless you're exempt)
