1. Visa Overview

THE VISA IS KNOWN AS
UK EXPANSION WORKER VISA

Step 1: Apply for 1 Year Initial Visa

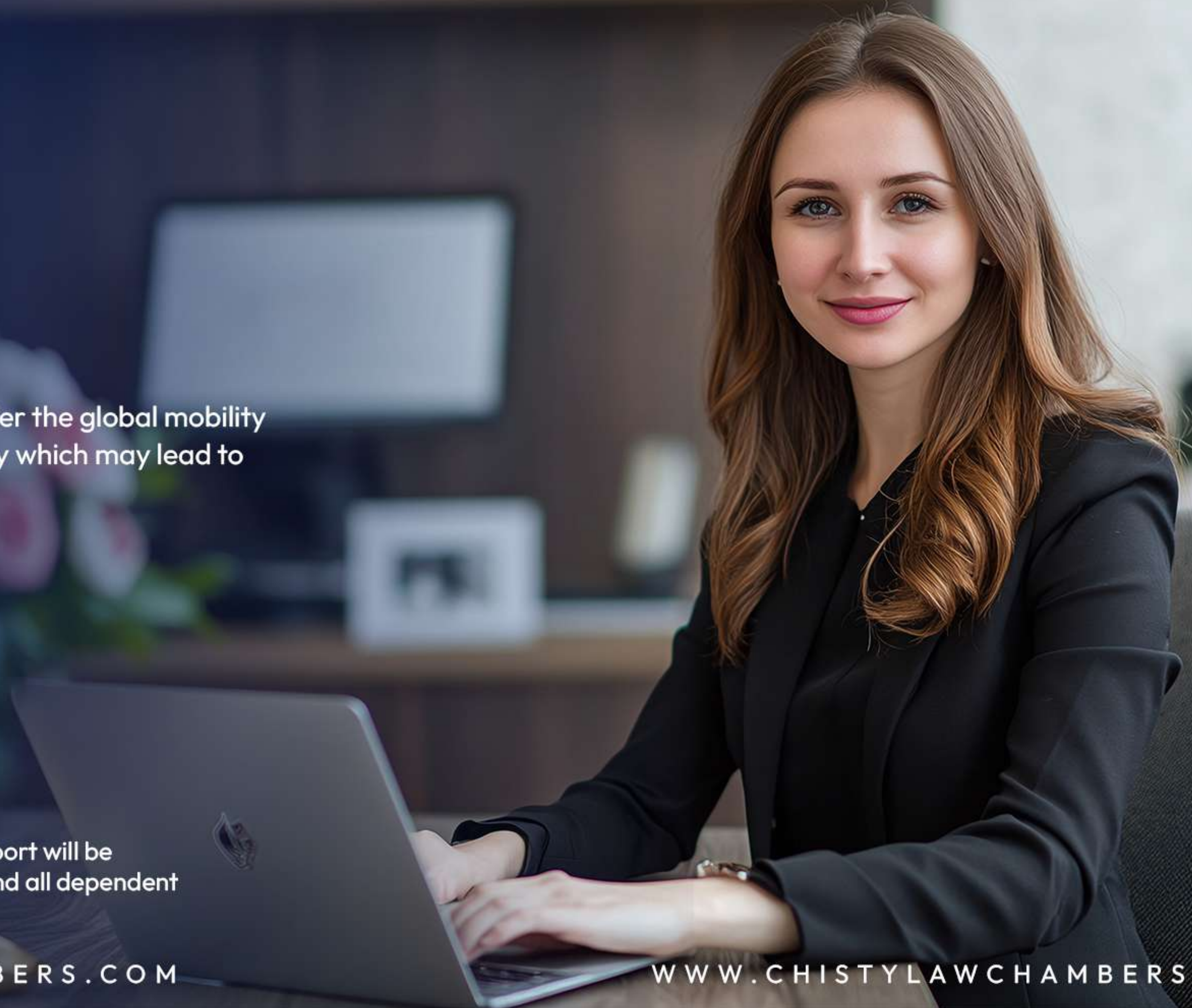
Step 2: Receive 1 Year Further Extension

Step 3: After 2 years, Applicant can apply under the global mobility Visa Categories or any other suitable category which may lead to settlement and then nationality.

EXAMPLE

- ◆ Senior or Specialist Worker Visa
- ◆ Skilled Worker Visa
- ◆ Innovator Visa
- ◆ Start-Up Visa

The above route to receive British Citizenship/ Passport will be applicable for the main applicant, his/her spouse, and all dependent children under 18 years of age.



2. Visa Benefits

- ◆ The Visa will be granted for the whole family (where applicable)
Below are some benefits:
- ◆ Wife / Husband Spouse may accompany the main applicant
- ◆ All Dependent Children under the age of 18 years old may accompany the main applicant
- ◆ FREE Medical*Healthcare for the whole family
- ◆ FREE Education for Dependent Children
- ◆ Spouse Dependent can work full-time in any job
- ◆ The Expansion worker can work full-time for its company
- ◆ Multiple entries visa
- ◆ Opportunities for business expansion in the UK
- ◆ Potential Route Leading to settlement and UK Nationality
- ◆ The Employer can sponsor multiple overseas business employees



3. Visa Basic Requirements

A) EXPANSION WORKER

An Overseas company sponsoring its Expansion worker to establish its first presence in the UK. The Applicant must already work for the overseas business either a senior manager or specialist employee.

B) REQUIREMENTS:

Have a valid certificate of Sponsorship from your employer

Do a Job that's on the list of eligible occupation

Be paid the minimum eligible salary required for your job

C) MAINTENANCE FUNDS:

Support your self when you arrive in the UK. you'll usually need to have at least £ 1,270 available (unless you're exempt)

D) BUSINESS PLAN:

A viable, credible and scalable business plan is required
