# 1. Visa Overview

With a Global Talent Visa, you can live and work in the UK. If you are a leader or potential leader in digital technology, such as

1. Financial Technology ('Fintech')
2. Gaming
3. Cyber Security
4. Artificial Intelligence

- ◆ The Initial Visa will be granted for up to 5 Years.
- ◆ A further extension of up to 5 Years can be applied before the expiry of the initial visa.
- ◆ After completing 5 Years, the Applicant will be eligible to apply for ILR (Indefinite Leave to Remain) in the UK. This also known as Permanent Residency.
- ◆ You can also apply for ILR after 3 Years, provided you fulfil specific requirements.
- ◆ After receiving ILR, an applicant can apply for UK citizenship after 12 months following a UK Passport.

The Above route to receive British Citizenship/Passport will be applicable for the main applicant, his/her spouse, and all dependent children under 18 years of age.





## 2. Visa Benefits

The Visa will be granted for the whole family (where applicable).

Below are some benefits:

- ◆ Wife / Husband (Spouse) accompanies the main applicant.
- ◆ All Dependent Children under the age of 18 years old accompany the main applicant
- ◆ Free Health Care\* for the whole family
- ◆ Free Education for Dependent Children
- ◆ The Main Applicant and the Spouse can work full-time as an employees or can be business owners.
  
- ◆ Multiple Entry Visa
- ◆ Indefinite Leave to Remain / Permanent Residency after 3 or 5 Years
- ◆ British Citizenship / Passport for the whole family





## 3. Visa Basic Requirements

The basic requirements for this visa are

### a) ELIGIBILITY CRITERIA:

You do not need a job offer to get a visa. Your background can be either:  
Technical, for example, you're a developer, engineer or data scientist  
business, for example, you have commercial, investment or digital product expertise in a technology company that creates software, hardware or processes data

Evidence of any digital technology company you have founded in the last 5 years or have been a senior member of

### b) ENDORSEMENT:

You need to apply for an endorsement to prove you are a leader or potential leader in your field.
